On 01.09.2022, TURSG shares with ₺ 300,000 nominal value were repurchased within a price range of ₺ 6.93 – ₺ 6.95 (weighted average ₺ 6.942) per share on Istanbul Stock Exchange by Türkiye Sigorta. Total repurchased shares reach to 0.29% of the capital.
