Pursuant to share buyback transactions revised with the resolution of the Company's Board of Directors dated 17.02.2023;

On 21.06.2023, TURSG shares with ₺ 100,000 nominal value were repurchased within a price range of ₺ 10.11 – ₺ 10.20(weighted average ₺ 10.16) per share on Istanbul Stock Exchange by Türkiye Sigorta. Total repurchased shares reach to 2.80% of the capital.
